- **DO NOT** attempt to push jack over obstacles. They are designed to be used on level surfaces only.
- Before moving, lower the load to the lowest possible point.
- Failure to heed these warnings may result in personal injury and/or property damage.
- Apply load as close to the vertical portion of the lifting member as possible.
- Before moving the load, assure that the load is centered and secured with a load restraint device.
- No alterations shall be made to this product.

ASSEMBLY INSTRUCTIONS:

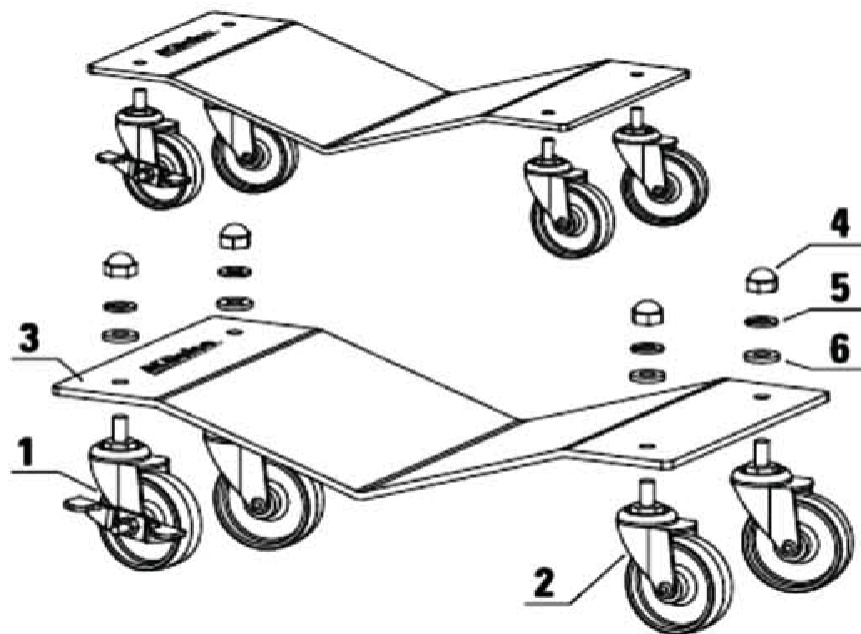
Secure the 4 steel casters to each dolly using the nuts, lock washers and flat washers as shown in the parts breakdown on the following page.

OPERATION:

1. Raise the vehicle with an approved jack or lifting device.
2. Place the auto dolly under each wheel of your vehicle, so the vehicle is well balanced.
3. The weight capacity of the each auto wheel dolly is 1500 lbs.
4. **DO NOT USE ON INCLINES, MUST ONLY BE USED ON FLAT, EVEN SURFACES.**

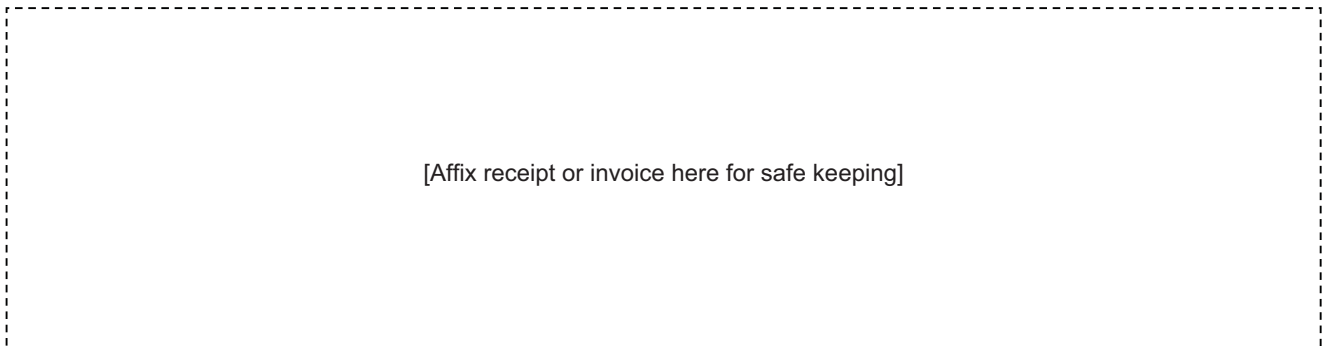
